Vs. Rif.: **Object: REGULATION (EC) n°. 1907/2006 concerning the Registration, Evaluation, Authorisation and Restriction of Chemicals (REACH)**

Dear Customer,

We confirm You that all the products We provide You are included in REACH Regulation EC n°. 1907/2006 and We assure You that all these products are REACH Compliant.

As You know, the European Chemical Agency published on 30/06/08 a list of 14 Substances of Very High Concern (SVHC List) that may become subject to authorisation. One additional substance was already identified as SVHC without Member State Committee involvement as no comments were provided during the public consultation. Many other substances have been continuously added to the list in the past 4 years. These substances have been included in such Candidate List (Annex XIV) in accordance with Article 57 of REACH Regulation and information sharing obligations are provided in Article 33. The aim of Article 33 is to ensure that sufficient information is communicated with articles to allow their safe use. So, as supplier of articles, We have the duty to communicate information on articles containing substances on the candidate list and We may have to forward required information available down the supply chain (Article 33(1)) and to consumers on request (Article 33(2)). Any supplier of an article containing a substance meeting the criteria in Article 57 and identified in accordance with Article 59(1) in a concentration above 0,1 % weight by weight (w/w) shall provide the recipient of the article with information including, as a minimum, the name of that substance. Particularly, as regard the new updating of Candidate List dated 16/12/2013 which has been published on the ECHA website:

We inform You that the hose:

80223.42921.01215 16173302 SPIRAL.KIT NEPTUN 1"7m 1/2bPLT

contains SVHC listed in a percentage under 0.1% (w/w).

Finally, with respect to Article 7, Par. 1 of Regulation REACH, We can make official statement that our Articles don't contain any substance intended to be released during normal and reasonable foreseeable conditions of use, so We aren't involved in any Pre-registration or Registration obligation as articles' Manufacturer and Importer.
